PRINCETON PROJECT 55 (PP55) FELLOWSHIPS (FORMERLY PUBLIC INTEREST PROGRAM AND PUBLIC HEALTH FELLOWSHIPS) THE MISSION OF ALUMNICORPS' PROJECT 55 FELLOWSHIP PROGRAM IS TO PROVIDE OPPORTUNITIES FOR RECENT PRINCETON GRADUATES TO DEVELOP A LIFELONG COMMITMENT TO CIVIC ENGAGEMENT AND TO PREPARE FOR CIVIC LEADERSHIP. SINCE OUR INCEPTION, WE HAVE PLACED MORE THAN 1500 ALUMNI IN THE PROGRAM WITH MORE THAN 550 NONPROFIT ORGANIZATIONS. THIS PAST YEAR, 42 FELLOWS COMPLETED THEIR FELLOWSHIP YEAR.
